Dear friends

I am delighted to be writing this introduction to the Catholic Union's 145th Annual Report.

At our AGM in November 2023, I had the great privilege of being appointed to serve as President of the Catholic Union. It is a particular privilege to be the first woman to hold this post in our 150-year history.

I am no stranger to the Catholic Union, having served as a Vice President for the past three years. I also had the pleasure of delivering the Craigmyle Lecture in 2022 on the theme of safeguarding in the Church – a subject close to my heart, having previously served on Pope Francis's Pontifical Commission for the Protection of Minors.

It is a great honour to be taking over as President from Sir Edward Leigh, who has done so much to support Catholic causes in Parliament and beyond. I know he will continue being a friend to the Catholic Union for many years to come.

Over the past few years, the Catholic Union has shown once again what can be achieved by lay Catholics getting involved in politics and public life. I'm looking forward to working with our fantastic members and supporters to build on this work.

A General Election year, and the start of a new Parliament and Government, makes this work all the more important. As you will see, the Catholic Union team will be busy getting to know new MPs and Ministers as our work to support Catholic parliamentarians and promote the common good starts again.

This year will also see the culmination of the Church's Synod on Synodality – a three-year process looking at communion, participation, and mission in the Church. I hope that the synodal focus on the role of the laity and the inclusion of people who sometimes feel marginalised within the Church will give us renewed confidence in the work of the Catholic Union.



There are so many opportunities in the Church and in the country for lay men and women to get involved and make a difference. All of us – and I mean all of us, are called to serve in some way.

I look forward to meeting as many of you as possible during my time as President – either in-person at one of our events or online in one of our webinars.

In the meantime, thank you for your continued support for the Catholic Union.

Review of the year

Overview

This has been a year of increasing impact for the Catholic Union across a broad range of activity. Building on the work that we have been doing to increase our capacity and profile, we are now beginning to see results and changes that will bring benefits to the Catholic community in this country and beyond.

As our success grows, so too has our reach with more people now engaging with our work than ever before. Our Weekly Briefing newsletter now goes out to over 5,000 people each week, many of our events this year have been fully booked, and membership numbers are growing.

With the formation of a new Parliament and new Government, the task of mobilising and representing lay Catholics in public life is all the more important. There is a great amount of work to be done in building relationships with new MPs and developing relations with those who have returned. We have already made a good start with over 600 parliamentary candidates engaging with our election guide.

We are working hard to meet and learn from the priorities of so many new Members of Parliament, especially from many new Labour and the Liberal Democrats – many of whom are Catholic. A new Parliament gives us the opportunity to revive a number of our campaigns – including getting the two-child cap on benefits lifted.

But this new Parliament will also bring its fair share of challenges, and there will need to be strong voices in support of the dignity of life, especially around the issue of assisted suicide. We will continue to be faithful and constructive witnesses to our work as we seek to bring about the common good.

Public affairs

The past twelve months have seen our public affairs and communications work go from strength to strength. One of the highlights has been our campaign to “Scrap the Cap” and allow new Catholic free schools to open. The campaign was launched in June 2023 and culminated in May 2024, when the Education Secretary announced an intention to lift the cap subject to consultation.

The campaign illustrated the purpose of the Catholic Union, uniting lay Catholics, the clergy and hierarchy, Catholic media, and the Catholic Education Service in a common effort, and doing the hard work outside the public eye and without fanfare, meeting ministers, parliamentarians, officials, and special advisers, to help improve policy. Given the new government’s different approach to education in general, and the balance between state and private schools in particular, it is as yet unclear what the outcome of the consultation will be.

Another overarching theme of our work this year has been the increased collaboration with other Catholic and Christian organisations which enables us to amplify the Catholic voice. For example, last year the Catholic Union, Christian Institute and Evangelical Alliance wrote to the Joint Committee on Human Rights about religious freedom in the workplace and in January 2024 the Catholic Union, the Catholic Bishops in England and Wales, CAFOD, and CSAN (Caritas Social Action Network) wrote to the Chancellor ahead of the March budget. We later welcomed the decision in the budget to scrap the High Income Child Benefit Charge, a change which the Catholic Union has called for over several years.

We also successfully collaborated with the Catholic Student Network earlier this year on a visit to Parliament for around 20 young Catholic leaders from universities across the country. When the previous Government proposed changes to the law around rough sleeping, we worked with a group of clergy from the West End of London to highlight their concerns over the effect that new offences could have on some of the most vulnerable people in the capital and across the country.

Following our efforts to reopen churches during the pandemic, we turned our attention to the UK Covid-19 Inquiry. Thanks to our increased reach, almost 1,000 people took part in our survey on Covid and Places of Worship. Almost two in three respondents said that the closures had impacted their health negatively, while 90 percent of people said that churches should never be forced to close again. We submitted the survey results as evidence to the Covid Inquiry and secured a guarantee that the closure and reopening of places of worship will be considered as part of their work.

We have also been working with others to promote religious freedom at work and we were at the UK's first Faith at Work Summit in March 2024 attended by over 100 business leaders, policy experts and faith representatives. We also participate in the UK FoRB Forum promoting freedom of religion or belief overseas.

A particular highlight of the year was being invited to address the Plenary Assembly of the Bishops' Conference of England and Wales at Hinsley Hall, Leeds in November. We had the opportunity to meet many bishops and to explain our work with a focus on the expected general election. Cardinal Nichols chaired the meeting and remarked on the "sense of purpose and partnership developing between the Bishops and the Catholic Union".

Finally, the Catholic Union strengthened its links with Catholic parliamentarians by being appointed to act as the secretariat for the All Party Parliamentary Group on the Holy See. We also welcomed the new Catholic Chaplain to Parliament, Fr Christopher Colven and paid tribute to the outgoing chaplain, Canon Pat Browne who has retired after many years of distinguished service.

Activities

Our cycle of events continued with a full audience for the 2023 Craigmyle Lecture given by Dame Rachel de Souza, Children’s Commissioner for England who spoke powerfully about strong families as the fabric for a healthy society and who used the occasion to launch the “Big Ambition” survey of young people in England.

At our packed to overflowing AGM held at the London Jesuit Centre, members were updated about our work and Bishop John Sherrington spoke about the work of the Church on Life issues. Also at the AGM, Sir Edward Leigh stood down after nine years as our President and Baroness Hollins was elected as his successor. Baroness Hollins has had an exceptionally distinguished medical career and has also served on the Pontifical Commission for the Protection of Minors. The AGM was followed by a Reception, sponsored for the first time by CCLA, the investment company. We said a proper goodbye to Sir Edward at a Reception held in the House of Lords in March and he was presented with a special Message from Pope Francis by the Papal Nuncio.

A new feature in our calendar was the Ampleforth Lecture held at Ampleforth College in March with Lord Deben (John Selwyn Gummer) speaking on The Gospel Imperative for Climate Action. This was a joint enterprise with the College and the Ampleforth Society and we look forward to similar collaborations in the future.

We continued our highly successful series of Pub Talks sponsored by The Catholic Universe which featured Catherine McKinnell MP in conversation with Christine Allen (CAFOD), Prof. Stephen Bullivant, Iain Duncan Smith MP with Benedict Rogers, actor Alex McQueen, Jon Cruddas MP and Lord Glasman. We also continued our regular webinars allowing members all over the country to take part and featured Christopher Trott (HM Ambassador to the Holy See), Raymond Friel (CEO of CSAN) and our new President Baroness Hollins.



Worth Abbey

Our 2024 Summer Gathering was held at Worth Abbey. Over 70 people gathered at the Benedictine Monastery in Surrey for a day of talks and reflections as well as Mass and an opportunity to explore the Abbey grounds. Keynote speeches were given by our President, Baroness Hollins, and by Abbot Christopher Jamison OSB, formerly the Abbot of Worth Abbey and currently the Abbot President of the English Benedictine Congregation.

Fundraising

All the activities described in this Report are only made possible by membership subscriptions and by generous donors, especially those who become members of our St Thomas More Circle.



The Circle was launched in 2019 and its members have been the key reason why the Catholic Union has grown in its output and impact over the last five years. New members have continued to join the Circle and

we have been especially pleased that, following a new fundraising campaign last Autumn, our members now include certain charitable trusts and foundations in addition to individual members. The Circle consists of three tiers of membership (Benefactors, Supporters and Friends) with corresponding levels of benefit. We would welcome new members of the Circle and full details are on our website. We would also welcome more sponsors for our events.

We now invite our donors to direct their contributions to the Catholic Union Charitable Trust (CUCT) and we also invite all members and supporters to consider leaving a legacy to the CUCT. All those who notify us of their decision to leave us a legacy are made members of our St Thomas More Circle.

Appointments

The last year has also seen some important changes in our team with Baroness Hollins succeeding Sir Edward Leigh as President and Tristan Feunteun succeeding Nigel Parker as Interim Director. We also have some new talent on our Council, notably Professor Francis

Davis and Dr Karen Singarayer who have become Vice-Chairs. In July 2024, we said goodbye to our Deputy Director, James Somerville-Meikle who is leaving us to begin a year's study at Valladolid. Also in July 2024 we congratulated Labour MP and a Vice President of the Catholic Union

Notes to the Accounts – Accounting Policies

- 1. Life Subscription Fund.** Income credited to the Life Subscription Fund on receipt is taken to the credit of the Income and Expenditure Account over a period of twenty five years in equal annual instalments commencing in the year in which the subscription is received.
- 2. Annual Subscriptions.** Annual subscriptions are taken to the credit of the Income and Expenditure account at the time of receipt.
- 3. Investment Income.** Investment income is derived from securities listed on the London Stock Exchange.
- 4. Tangible Fixed Assets.** Depreciation on office equipment is provided at 33% on cost per annum in order to write off each asset over its estimated useful life.
